

Day by Day Itinerary

Thurs., Sept. 8 - CHICAGO / EN ROUTE

We depart Chicago's O'Hare International Airport this evening by scheduled service of United Airlines on the overnight transatlantic flight to Dublin, Ireland.

Fri., Sept. 9 – DUBLIN / GALWAY

(I,HD)

Shortly after the sun rises on the Irish coast we arrive in Dublin where we'll meet our Driver Guide who will accompany us throughout our vacation. Leaving Dublin, we'll travel across the Midlands, often considered the cradle of Irish civilization and the Celts' spiritual home. Along the way, we'll stop to visit the medieval monastery of Clonmacnoise that once served as a crossroads of routes linking all of Ireland. Afterward, we're headed to County Galway. The city of Galway lies on the banks of the River Corrib, and following an extensive restoration in the early 70's, the narrow and winding streets of this once-walled city have been brought back to life.

Sat., Sept. 10 – GALWAY (Connemara)

Today we explore the rugged yet serene Connemara region. This rocky land of broad-backed mountains and pearl-like lakes is the largest Irish-speaking section of the country and the traditional ways of life are as much a part of this region's attraction as is the scenery. We'll begin our day by traveling along the shores of Galway Bay before stopping in the town of Spiddal for a view of the Aran Islands. Then we're headed to picturesque Kylemore Abbey, a castellated neo-Gothic mansion occupied by an Irish Benedictine community of nuns, where we'll have an opportunity to walk the abbey grounds. On our return to Galway, we'll stop in the town of Moycullen to visit the Connemara Celtic Crystal Factory, a family business specializing in designs based on the shamrock, the Claddagh ring, and harp, to learn of their time-honored tradition.

Sun., Sept. 11 – GALWAY / KILLARNEY

This morning we depart Galway and travel through the Burren, a vast limestone plateau in northwest County Clare, as we make our way to the Cliffs of Moher. Even when shrouded in mist or buffeted by gales, the Cliffs of Moher are a breathtaking sight as they rise to a height of 650 feet from out of the Atlantic. Here, we'll enjoy a visit to the eco-friendly Visitor Centre and Cliffs Exhibition that brings the story of the cliffs to life. Following our visit, we'll travel inland to County Limerick where we'll enjoy an afternoon refreshment at Durty Nelly's in the shadow of Bunratty Castle. Then we'll follow the fabled River Shannon south through the picturesque village of Adare on our way to County Kerry and the town of Killarney. Set in the scenic southwest, it is here where we'll find some of the most picturesque views in all of Ireland.

Mon., Sept. 12 – KILLARNEY

(Blarney Castle & Cobh Heritage Center) (B) A leisurely day on tour will take us to neighboring County Cork for a visit to fabled Blarney Castle. We'll have an opportunity to climb the steps of the fortress to see the world-famous Blarney Stone. Just a stone's throw away we'll also visit the Blarney Woolen Mills, the largest emporium of Irish crafts in the country where we can browse the finely woven Irish woolen products or relax at one of its welcoming pubs. Then, we're headed to the port town of Cobh, the last stop for the Titanic before its doomed Atlantic crossing in 1912, where we'll visit the Cobh Heritage Centre tracing the history of emigration from Ireland to the United States. Following our visit, we'll return to Killarney for an evening at leisure.

Tues., Sept. 13 – KILLARNEY

(Ring of Kerry & Jaunting Car Ride)

The Ring of Kerry on the Iveragh Peninsula is often considered one of the finest coastal tours in all of Europe as it is full of both captivating mountain and coastal scenery. Dramatic seascapes, slate-roofed fishing villages and plenty of black-faced sheep appear around every bend as we return to the Atlantic coast. We'll also take in the magnificent fourmile silver strand beach of Rossbeigh before stopping for an afternoon break in Waterville, located on both the Atlantic shore and along one of the loveliest lakes in Ireland. This afternoon we'll travel inland with stops at scenic Molls Gap and Ladies View, the best place to enjoy a panorama of the Killarney Lakes. On our return to Killarney we'll leave our motorcoach behind and enjoy a Jaunting Car ride filled with history, legend, and folklore.

Wed., Sept. 14 – KILLARNEY / DALKEY (B,L,HD) This morning we depart Killarney and travel to County Tipperary to visit the Rock of Cashel. A symbol of royal and priestly power for more than a millennium, the Rock enabled Cashel's inhabitants to scour the surrounding plains for potential invaders. After lunch, we'll be on our way to Kilkenny, undoubtedly Ireland's loveliest inland city. An introduction to Kilkenny will take us past the Dominican Black Abbey and St. Canice's hilltop cathedral before reaching Parliament Street, home to the Rothe House, a unique Irish

merchant's townhouse. Then we'll travel along High Street dominated by the 18th century Tholsel, before reaching The Arcade where we'll stop to visit magnificently restored Kilkenny Castle. Free time will also be set aside to explore adjacent Castle Yard, the former stables and coach houses that are today home to the craft studios and workshops of the Kilkenny Design Centre. Our day will come to an end as we travel to County Dublin, where we'll stay at the Fitzpatrick Castle Hotel, billed as Dublin's finest castle hotel.

Thurs., Sept. 15 – DALKEY

(Irish National Stud with A Day at the Races) (B) Today we set our sights on County Kildare and begin with a visit to the Irish National Stud. As we'll soon learn, Ireland has a strong horse racing culture, and County Kildare is world famous for staging the most exciting horse racing events in Ireland. A tour of the grounds will allow us to see the next champions as they are being exercised, as well as explore the special foaling unit, and the farm's forge and saddlery, before stopping at the Horse Museum. This afternoon, we'll visit Naas Racecourse, known as the Nursery of Champions, to experience the colorful and exciting spectacle of thoroughbred racing.

Fri., Sept. 16 – DALKEY (Dublin)

Our day begins with a short journey into the capital of Dublin for an introductory tour of this famous city on the River Liffey. Highlights on tour will include the Bank of Ireland built in 1729 and formerly the Irish Parliament, the National Museum, Dublin Castle, and Four Courts built in the 18th century and now housing the High Courts of Justice. We'll also visit Trinity College's Old Library to view the Book of Kells, the most richly decorated of Ireland's medieval illuminated manuscripts, as well as St. Patrick's



Cathedral. We'll end our tour with a visit to the Guinness Storehouse to experience the Guinness Story and the brewing process before finishing with a sampling of their wonderful stout in the Visitors Bar. Following our tour, time at leisure will allow us to stroll pedestrian Grafton Street where we'll find plenty of shopping and Bewley's Café Theatre, a city landmark.

Sat., Sept. 17 – DALKEY / CHICAGO

Early this morning we depart Dalkey and travel to Dublin Airport in preparation for the return journey home. No better time to reflect on memories of our *Ireland Escapade* to last a lifetime and new friendships made along the way!
